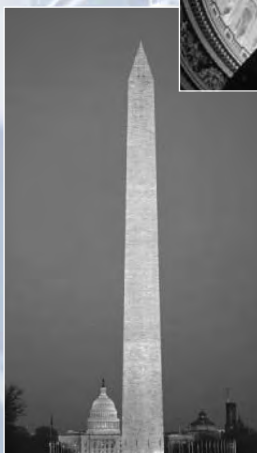

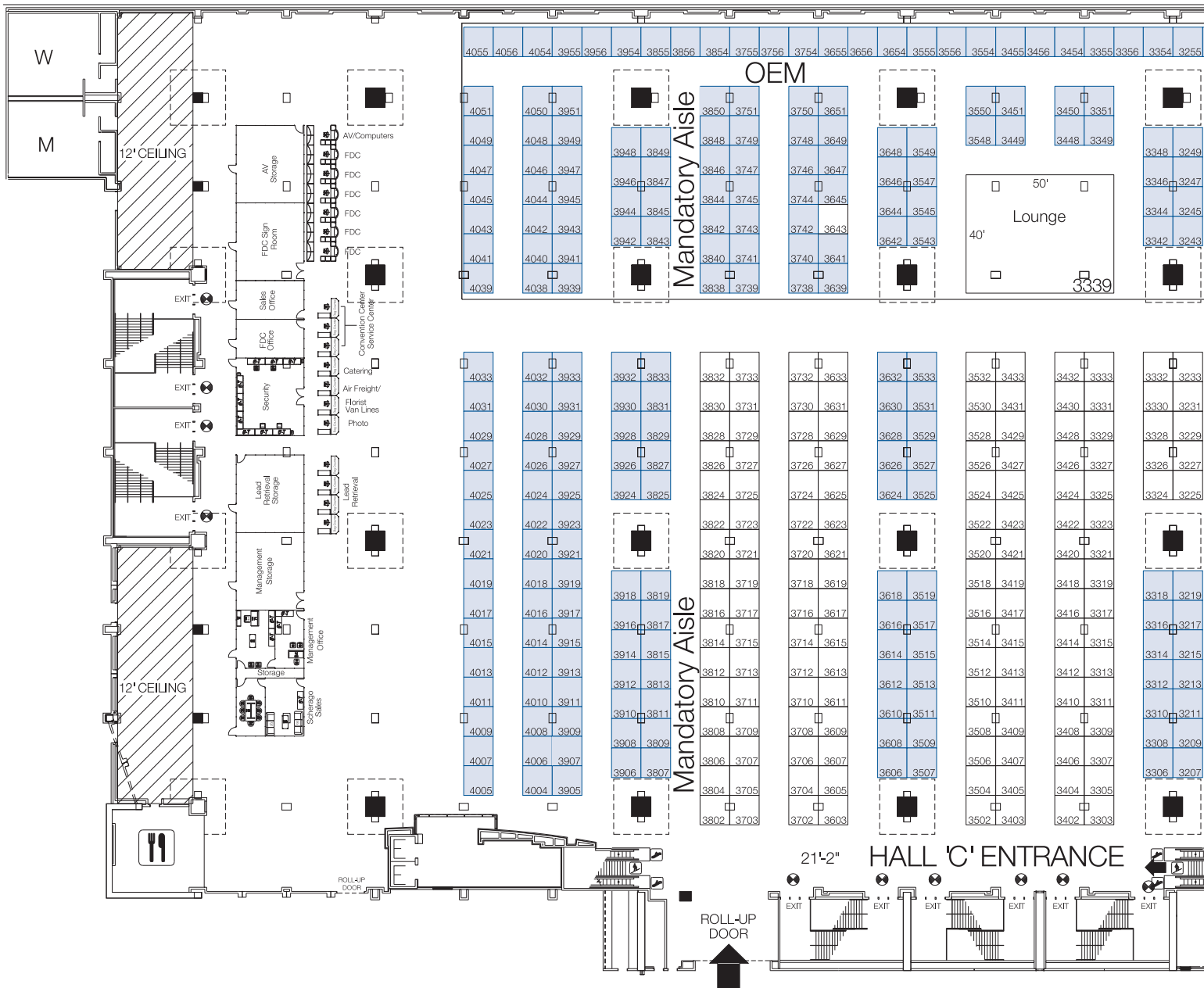


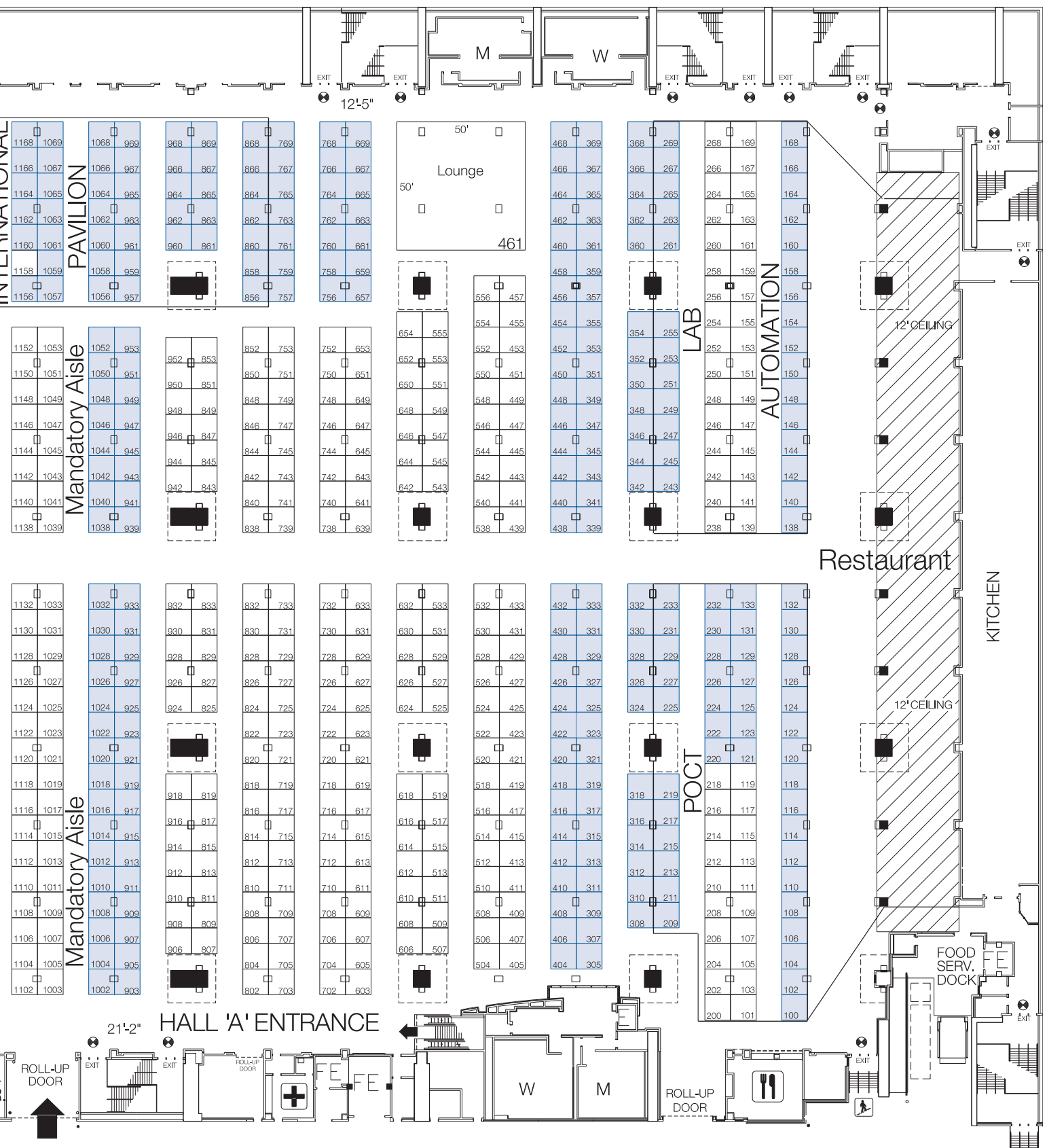

This floorplan indicates the overall layout and relative positions of the booths, poster area, special sections, and other features within the exhibit hall. This layout is preliminary and may change based on final booth requests and fire/safety regulations.

- There are three entrances to the exhibit hall marked at the bottom of the diagram as Hall A Entrance, Hall B Entrance and Hall C Entrance. There are no dividers or barriers between the halls.
- Solid black squares and rectangles indicate columns. The dotted lines surrounding the columns indicate space that must remain clear for access to fire and safety equipment within the columns.
- Special interest sections are indicated on the floorplan: Point-of-Care (POCT); Lab Automation/Robotics/ Informatics (Lab Automation); International Pavilion; and OEM/Biotech/Research (OEM). All other space is IVD/General Laboratory.
- There are no dividers or barriers between the special interest sections. They are indicated by different carpet colors in the aisles and by banners hanging over each special interest section.
- Shaded booths are reserved for non-island booths.
- White or unshaded booths are reserved for island exhibits. Aisles between white/unshaded booths may change or be eliminated depending on the placement of island exhibits.
- Mandatory aisles indicated on the floorplan cannot be crossed by island exhibits.
- The AACC and ASCLS booths are not indicated on the floorplan because they will be sized and positioned depending on exhibitor booth sales.
